### **GMCAC partners with four Lapu-Lapu schools for Brigada Eskwela Campaign**

MACTAN, Cebu – A total of 128 employees of GMR-MEGAWIDE Cebu Airport Corp. (GMCAC) volunteered in this year's classroom maintenance program of the Department of Education (DepEd), also known as Brigada Eskwela 2016.

GMCAC partnered with four elementary schools in Lapu-Lapu City from barangays Pusok, Basak, Buaya and Ibo during the four-day Brigada Eskwela campaign held from June 1 to 4.

Employees took turns doing general clean-up, repainting of classroom walls, repair of broken chairs, and removal and disposal of construction debris, among others.

Brigada Eskwela is an annual maintenance program initiated by the DepEd that invites and engages partners and education stakeholders to contribute their time and efforts to help create a good learning environment for elementary and high school students in time for the opening of classes.

GMCAC – which is 60% owned by listed Filipino construction company Megawide Construction Corporation and 40% by Bangalore-based GMR Infrastructure Limited – won a 25-year concession agreement to renovate MCIAT Terminal 1.

Last year, GMCAC has started work on MCIAT Terminal 2 to boost the airport's passenger carrying capacity to 12.5 to 13 million a year from the current 4.5 million by October of 2018.

MCIAT is envisioned to become the world's friendliest airport gateway that demonstrates the warmth and hospitality of the Cebuano people. (End)

**GMR Megawide Cebu Airport Corporation (GMCAC)** is a Filipino company formed from the Consortium comprising of GMR group of India and Megawide Construction Corp. of the Philippines under the Public Private Partnership (PPP) with the Department of Transportation and Communication (DOTC). GMCAC won the 25-year concession to rehabilitate and manage terminal operations at the Mactan Cebu International Airport (MCIA), including the construction of a second, bigger terminal, T2. The company took over management of the MCIA passenger terminal and related areas on November 1, 2014.

Since the project was turned over to GMCAC, there are various upgrades and changes that have been implemented: greener terminal building with new seats, washrooms are being renovated, new self-service check-in kiosks have been installed, new immigration, customs and quarantine counters are in place, improved baggage handling system, new flight information displays, expanded retail options, among others.
